2020 year in review - meeting the challenge

In a uniquely difficult year, our community stepped up to meet the challenge. 2020 brought generous giving, by donors both longstanding and new, increasing YVCF's ability to leverage donations and create significant impact. In 2020, YVCF's total assets grew 34% to \$28M and total grants awarded increased 66% to \$2.5M.

YVCF TOTAL ASSETS 1997-2020

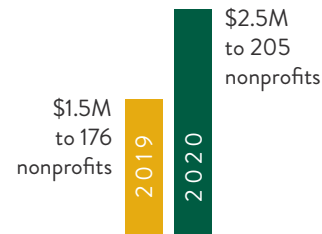

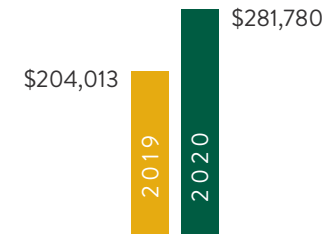

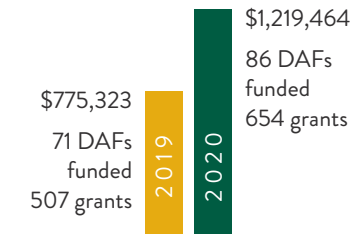

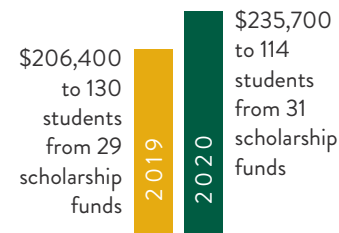

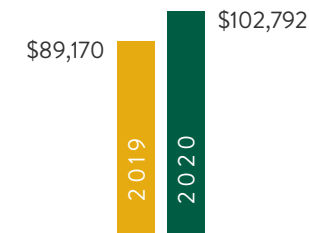

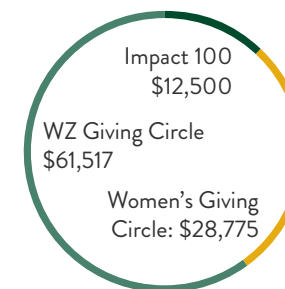


GIVING CIRCLES ▲ \$13K

In March 2020, seemingly overnight, our daily lives changed dramatically as the global pandemic drove closures of schools and businesses. As is frequently the case when confronted with a crisis, our community looked to YVCF to be a central point of collaboration and response. YVCF acted swiftly to open the COVID-19 Response Fund. The Fund served as a vehicle for accepting donations and, in coordination with local funders and in partnership with Routt County United Way and Moffat County United Way, enabled rapid direction of those funds to where they were needed most. In total, the Fund received donations from over 300 individuals and awarded 51 grants totaling \$399,694. The grants were directed to organizations on the front lines of COVID-19 prevention, containment, and response, and were specifically aimed at supporting the Yampa Valley region's most vulnerable and impacted populations.

grantee highlights



BOYS & GIRLS CLUBS OF NW COLORADO

The Boys & Girls Clubs received \$26,064 in funding to reopen the Craig and Steamboat facilities and continue offering programming and transportation with safety protocols in place.



SOUTH ROUTT MEDICAL CENTER

A general operating grant of \$14,000 enabled the clinic to stay open and provide essential healthcare to the community as well as expand PCR and rapid COVID testing capacity.



ROUTT COUNTY COUNCIL ON AGING

Two grants totaling \$9,260 for COVID-safe grocery home delivery helped feed 150 older adults and facilitated wellness checks and connectivity for isolated elders.

impactful grantmaking

Grantmaking is at the heart of the Yampa Valley Community Foundation's work to enhance the quality of life in Northwest Colorado. Impactful grantmaking begins with trusted partnerships with nonprofits, through which we identify funding and training needs, and deep relationships with donors, fund holders and giving circle members, with whom we facilitate scholarships and grants large and small. Our expertise in effective philanthropy enables us to grant meaningfully year-round, to pivot during a crisis or a unique opportunity, and to direct funds where needed most.

At the end of 2020, a new opportunity arose for every Routt County kindergarten student to learn to ride a bike. Through a coordinated community effort, donors and grants came together to fully fund the All Kids Bike Learn-to-Ride program. The program removes barriers and levels the playing field for all kids in the community.

meaningful philanthropy

The Yampa Valley Community Foundation is passionate about connecting donors with giving opportunities aligned with their unique passions and vision. We help individuals, families, and businesses create personalized plans for their philanthropy with the goal of building a culture of engaged giving.

YVCF currently manages over \$31 million in donor-advised funds, scholarship funds, agency endowments and other charitable funds. We facilitate three circles of collective giving, host donor education and engagement events, steward unique gifts such as appreciated stock and real estate, and work with donors to create legacy gifts for lasting impact beyond their lifetimes.

In 2020, YVCF facilitated the donation of real estate from philanthropist Dr. Dana Shires and worked creatively to meet the donor's unique philanthropic vision, resulting in the establishment of two new endowment funds for Steamboat Digs Dogs and the Steamboat Youth Hockey Association as well as charitable support of YVCF's mission.

sustaining nonprofits

We are the trusted resource for local nonprofit organizations in Routt and Moffat Counties, increasing nonprofit effectiveness and fiscal sustainability and helping them amplify their impact in the Yampa Valley. We serve nonprofits in a variety of ways – encouraging capacity and endowment building, providing funding opportunities via grant cycles and collective giving circles, and offering fiscal support through management of endowment funds and planned giving partnerships.

YVCF spearheads Yampa Valley Gives, a Regional Champion for the statewide Colorado Gives program. This effort provides marketing and logistical support to nonprofits so they can be more effective in their fundraising on Colorado Gives Day and throughout the year. In 2020, its sixth year, YV Gives reached a new milestone, raising over \$1.1 million for 78 nonprofits in Routt and Moffat Counties. The program has become the largest fundraising event of the year for many of the nonprofits that participate.

ADVOCATES OF ROUTT COUNTY

More than a check writer—a collaborator. The Community Foundation partners with local nonprofit organizations to achieve a shared community vision. In 2020, in direct response to the COVID-19 global pandemic, we modified our community grant cycle to provide flexible unrestricted grants, recognizing that our grant recipients are best equipped to decide how their grant awards should be spent and, particularly true in 2020, need flexible funding to respond to unique and immediate challenges.

As the sole provider of domestic and sexual violence victim services and prevention programming in the county, Advocates of Routt County witnessed a large spike in the incidence and severity of domestic violence in 2020 and experienced a near doubling of calls to their crisis line. Due to the global pandemic's stay-at-home order, many victims found themselves isolated at home with their abusers, unable to escape violence or easily access help. A \$5,000 unrestricted grant helped Advocates address the increased demand for their services all while launching the Brighter World Child Advocacy Center to serve child victims of violence and abuse in Northwest Colorado.

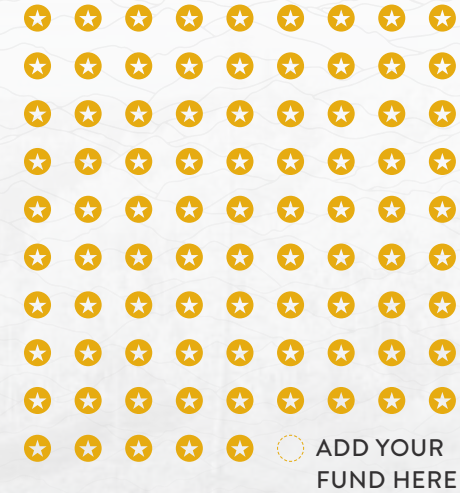

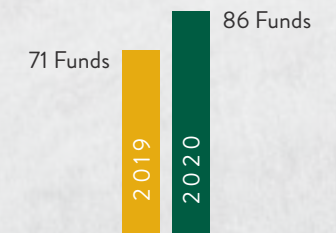
