

dear friends

For the Yampa Valley Community Foundation, 2021 will be remembered as a record-setting year of growth. Total assets held by YVCF grew by 80% from \$28.8 million in 2020 to \$51.8 million in 2021.

But asset growth is a limited metric. Far more relevant to our mission are measures of dollars put to work preserving the community we all care about. In 2021, we raised substantially more money for our Community Grant Cycle allowing us to grant out \$466,000 to 74 nonprofits, up from \$281,780 in 2020 (a 65% increase). Nearly all those grants provided unrestricted operating support which is generally more difficult to raise and thus particularly appreciated.

Our DAF advisors stepped up this year as well. Working together to find opportunities that not only make the biggest difference for our community but that were closely aligned with their own personal passions, we facilitated \$9.2 million in grants, vastly eclipsing the 2020 total of \$1.2 million.

In this year's annual report, you'll learn more about the issues on which we exercised the organization's fundraising muscles. For example, we were proud to orchestrate a \$24 million grant from an anonymous donor for the Yampa Valley

Housing Authority's purchase of the Brown Ranch property (page 11). We also leaned into fundraising targeted at specific initiatives that involved multi-jurisdictional collaborations, were regional in scope, and reinforced Yampa Valley shared values such as helping the South Routt and Hayden School Districts with Yampa Valley RISE (page 7).

2021 witnessed an important growth step in another way. In October the Board of Trustees kicked off an effort to establish a new headquarters in the center of Steamboat Springs. The project, made possible by the generous donation of land at 4th and Oak Streets, is further described on page 31. As we write this letter, we are wrapping up our fundraising campaign and look forward to breaking ground this summer.

YVCF works every day to preserve the shared community values that make our valley such a special place to work, live, raise a family, and enjoy the beauty of our surroundings. Everything we accomplished in 2021 is due to our partnership with dedicated community members like you. Thank you for your inspiration, thoughtfulness, compassion, and generous spirit.

impactful grantmaking

YVCF relies on our longstanding and trusted partnerships with nonprofit organizations in the region to stay informed of issues affecting the Yampa Valley and to guide thoughtful and intentional grantmaking. In addition to our annual Community Grant Cycle, we grant throughout the year via designated endowments, giving circles, and granting funds, as well as partnering with our Donor Advised Fund (DAF) advisors to help meet funding needs.

BookTrails promotes a love of literacy through day and overnight summer reading camps held at their off-the-grid Reading Ranch. Over the course of 2021, BookTrails received grants from YVCF's Community Grant Cycle, IMPACT100 giving circle, and DAFs to support their Scholars Program for English language learners who show deficiencies in reading skills, and for their Reading Ranch Capital Campaign which will allow them to serve an additional 100 youth each summer.

meaningful philanthropy

The Yampa Valley Community Foundation is passionate about helping donors identify funding needs and opportunities to give that align with their values and will make a significant impact. The most effective philanthropy is not simply giving but giving in a way that resonates with a donor's personal interests and fosters pride and fulfillment.

In 2021, YVCF partnered with South Routt and Hayden School Districts to promote Yampa Valley RISE, an opportunity to leverage an existing grant and significantly expand Career & Technical Education (CTE). Because a \$1.05M grant from the State could not be used for capital expenditures, YVCF reached out to donors passionate about education and agriculture to help raise \$900,000 for construction and renovations of career pathway labs and facilities. South Routt and Hayden will be the first school districts in Colorado to offer all 6 CTE pathways under Agriculture, Natural Resources and Energy.

sustaining nonprofits

Supporting a vibrant nonprofit community is at the heart of the Foundation's mission. Above and beyond direct financial support for general operations and programs, YVCF provides training and tools to help our nonprofit partners establish and grow endowments for long-term sustainability. Endowments held at YVCF benefit from our administrative services and professionally-managed pooled investment, allowing nonprofits to focus on operations and fundraising.

At the end of 2021, YVCF wrapped up its five-year Nonprofit Endowment Building Incentive Program, having contributed a total of \$101,000 in partial-match funding to seventeen agency endowments. The Tread of Pioneers Museum utilized our Endowment Building Toolkit to raise over \$50,000 and receive the full \$10,000 match. The program successfully increased awareness among donors to the value of endowments and legacy giving, while the incentive was an additional boost of encouragement for nonprofits to establish long-term financial stability.

building community

A shortage of affordable and attainable housing has become one of the most vexing issues in many regions in Colorado, particularly in ski resort communities. Drawing on our greatest strengths – our personal connections with donors, deep knowledge of issues in the region, and an individualized approach to philanthropy – YVCF played a vital role in a long-term solution to one of Routt County’s greatest community challenges.

In 2021, YVCF served as liaison and grantor for an anonymous donation of \$24M to the Yampa Valley Housing Authority (YVHA) for the purchase of 536-acre Brown Ranch. The property will be thoughtfully developed into a wide array of housing options and services under YVHA’s leadership and a committee of community volunteers. YVCF is proud to have sparked the generous and impactful donation that’s now a key part of solving the area’s affordable housing problem.

HORIZONS SPECIALIZED SERVICES – MOFFAT COUNTY

Our annual Community Grant Cycle is YVCF's opportunity to provide direct support to nonprofits serving Routt and Moffat Counties and to listen, learn, and respond to their evolving needs. In the last two funding cycles, we began providing unrestricted grants and increased the maximum award amount to \$7,500, following a philosophy of trust-based philanthropy and recognizing the need for flexible funding. Generous funding from Steamboat Resort, Donor Advised Fund advisors and YVCF granting funds enabled \$466,000 to be awarded in 2021, a 65% increase over 2020.

Horizons Specialized Services works to expand opportunities for individuals with developmental delays and disabilities (IDD) across Northwest Colorado. Horizons is committed to the End the Wait Campaign's goal of enrolling all eligible individuals in IDD services and housing. A \$7,500 unrestricted grant in 2021 supported Horizons as they explore options to increase capacity, including developing new housing, implementing innovative service delivery models, and increasing wages to help hire and retain a highly trained and skilled workforce.

After Amy Satkiewicz lost her husband Mark to a cardiac incident while cycling in 2020, she wanted to continue his legacy of removing barriers and creating equal opportunities for youth to participate in dirt and snow sports. Since launching the Dirt to Snow – Mark Satkiewicz Legacy Fund at YVCF in January 2021, Amy has become a model of philanthropy-in-action. Spurring collaboration and providing funding to local youth-serving organizations, Amy has been integral to the success of several initiatives including the Boys and Girls Club’s Summer Bike Program, Routt County Riders’ Bike Match and Integrated Community’s Newcomer Ski Day. Amy’s philanthropy through Dirt to Snow serves as a powerful role model for their teen daughters and continues Mark’s quest for inclusivity and access to the sports that defined so much of his life.

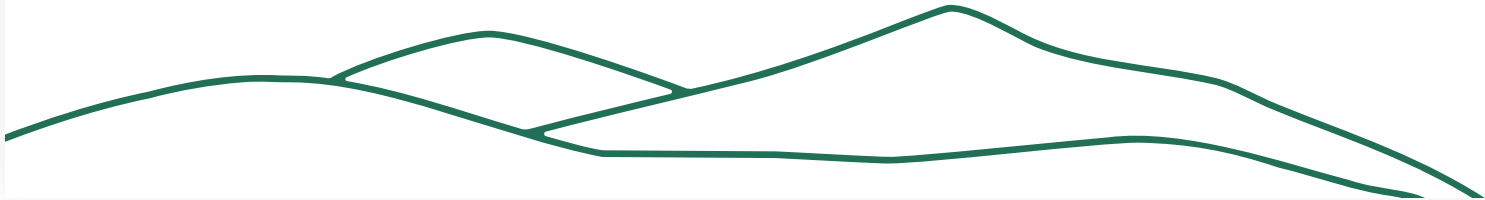

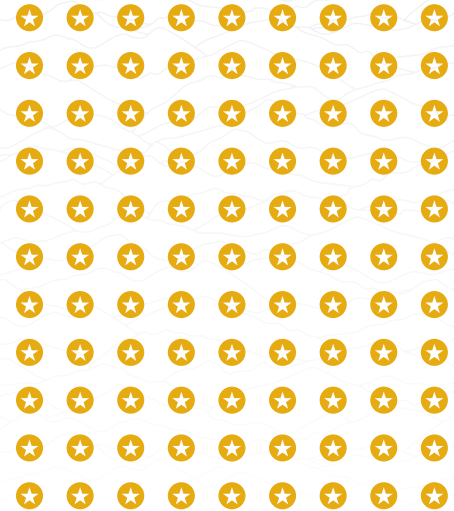

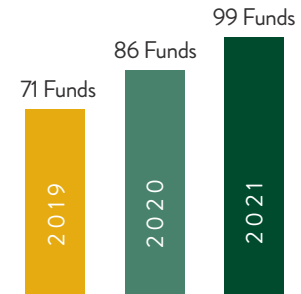
