1. THROUGH OUR ANNUAL GRANT CYCLE, OVER \$531,000 WAS GRANTED OUT TO 74 NONPROFITS.

2. OVER \$358,000 IN SCHOLARSHIPS WERE GRANTED. A 14% INCREASE OVER LAST YEAR.

3. IN TOTAL, \$6.28 MILLION WAS GRANTED OUT TO 260 NONPROFIT ORGANIZATIONS IN 965 GRANTS THROUGH FUNDS MANAGED BY THE FOUNDATION.

4. THE FOUNDATIONS' PASSPORT CLUB, THROUGH OUR PARTNERSHIP WITH THE STEAMBOAT SKI & RESORT CORPORATION HAS GENERATED OVER 9 MILLION DOLLARS. THESE CONTRIBUTIONS HAVE PROVIDED GRANTS AND SCHOLARSHIPS INTO THE COMMUNITY AND SUPPORTED THE OPERATIONS OF THE FOUNDATION FOR OVER 26 YEARS.
